

Southern Zone Board of Review

Jurisdiction. Before filing a Petition, please consider whether your concern is within the jurisdiction of the Zone Board of Review:

Matters involving a member or members of only one Zone, matters arising in regional or zone competition and any complaint alleging a violation(s) of Article(s) 304.3.11 through 304.3.15 inclusive of the USA Swimming Code of Conduct involving one or more members or prospective members of the Zone, and/or one or more Participating Non-Members, and not brought by USA Swimming.

The resolution of any dispute regarding jurisdiction of the Zone or the National Board of Review with regard to a particular case shall be determined by the Chair of the National Board of Review, which resolution shall be binding on all parties and non-appealable.

Petition Review. Once the completed Petition (including filing fee) is received, the Chair may review, dismiss or suggest modifications to the Petition to assure that the Petition sets forth a cause of action under USA Swimming rules. Any dismissal by the Chair may be reviewed by a Zone Board of Review panel upon request of the Petitioner(s).

Hearing Notice. If a hearing is necessary, the Chair of the Board of Review will send a written Notice of Hearing to the Respondent(s) with a copy to the Petitioner(s). The hearing will take place between 30 and 60 days of the Notice.

Pre-Hearing Notice. If a hearing is necessary, the Chair of the Board of Review may also send a written Pre-Hearing Notice setting forth, among other things, the applicable deadlines for Respondent(s)'s Response and Petitioner(s)'s Reply (if any), pursuant to Articles 406.3.1B and 406.3.1C of the Rulebook.

Hearing. The hearing will be held via telephone conference, with the presiding officer and hearing panel, Petitioner(s), Respondent(s), and any attorneys for the Petitioner(s) and/or Respondent(s). The Petitioner(s) and/or Respondent(s) may also have witnesses present, if necessary.

Decision. A written Decision will be delivered within 14 days of the hearing.
